Activity Report 2022

	☐ The AGM supported the idea of closer cooperation with other chambers to attract more people to the events.		
	Active member in FICE		
	☐ The goal is to get more companies to fill out the annual survey and DECC members are encouraged to participate in the FICE events.		
	Search for a new manager – full time or half time		
	□ As of now we are not activ searching, but we are saving money so that we can offer a normal salary for a half-time manager, and in time the new manager can increase the working hours and the income.		
	Merge with NECC – current environment for cooperation is difficult due to the NECC pulling out of FICE		
	☐ Still on the table, but for now we are waiting for NECC new board to make an opinion on this issue. The AGM is agreeing that it would be a good solution for both chambers, but it must be done on a common and friendly way.		
	Christmas Party		
	☐ Date to be decided before August.		
	More social events than business related events?		
	□ DECC will focus a bit more on social event – for Dane in Estonia, and we will try to attract more members from the Danish community who are bit "afraid" of DECC as it is a chamber of commerce. By inviting all Danes to the social events, we car have more members.		
	The business related events can be held in cooperation with other chambers and under the FICE name.
